This application form is for the Kerry-Limerick combined SHEP Foundation Part Two certificate in Social Awareness and Community Empowerment (SACE) course in Spring 2024. The course is open:

- A. **To people who have already completed SHEP's Foundation Part One the Certificate in Personal Development.** This course here is Part Two of the SHEP Foundation Program in Social and Personal Health Education. For these, it is a continuation of their personal journey of growth and development, through deepening awareness of the wider social relationships with which we are all involved.
- B. To people as an alternative entry point to SHEP's Foundation Programme pathway than the Personal Development course, so as to include participants whose main starting interest is their community, their involvement in a local organization, and want to bring deeper awareness to that involvement.

# **Course Details**

- The course fee will be €550
- This is the same as in 2022. All SHEP courses are subsidized by HSE core funding to the Project In this instance there is also support from the MWRDAF.
- There are limited SHEP bursaries available in Spring 2024 and these need to be applied for
- Please see the Bursary Rate Fee information below for eligibility
- Where awarded a SHEP bursary the fee reduces to €250 (i.e. on award of a bursary of €300)
- There is no booking deposit.
- The course is facilitated by 2 SHEP trainers accompanied by apprentice trainers
- The course is 74 hours (approx. 60% in-person) to facilitate ease of participation given the geographic spread of the participants
- Runs from February 2024 to April 2024 (see schedule below)
- The group will have 18-24 participants

The Spring 2024 course, as well as being the first opportunity in recent years to complete the SHEP Foundation Program locally, will prepare people to meet the prior requirements for the combined Kerry-Limerick SHEP Certificate in Facilitation course that will commence immediately this course completes. That course will run to December 2024 and will prepare people to meet the prior requirement for the next Tutor Training programme that will be offered by SHEP in Spring 2025.

# **Option One - SHEP Bursary**

SHEP recognises that for some people, the course fee, even though it is a subsidised fee, may still be prohibitive. To make our courses accessible we offer a bursary rate on <u>some</u> SHEP courses offered in Cork, Kerry and Limerick. For the Limerick-Kerry SACE course in Spring 2024, bursary rate places for Kerry are funded by the SHEP Bursary Fund (to which people and companies have made donations), For Limerick, Clare and Tipperary applicants (Mid-West region), bursary rate places are funded by the support of the MWRDA Forum to the SHEP programme in that area. SHEP Bursaries for the 2024 SACE course where awarded amount to €300, reducing the course fee payable to €250.

# Important Information on SHEP Fees & Payment Methods Limerick-Kerry Spring 2024

#### Summary

Thank you for your interest in training, or further training, with SHEP. Our philosophy is to keep our training **as affordable and as accessible as possible**. The vast majority of our courses have a participant fee which we try to keep to a minimum). We believe our training offers tremendous value for money. In general, the training fee to each participant is less than  $\in$ 8 per hour.

Because we are core-funded by the HSE, **all SHEP courses are subsidised**. Every participant benefits from this HSE support because without it the standard course fee for all courses would be significantly higher.

The HSE core grant to SHEP is used to cover most of the coordination and administration costs of SHEP courses. Fees collected from participants are used to pay the costs of the two Trainers (and where applicable the module Trainers) who co-facilitate the course and to contribute towards costs such as supervision, promotion, administration, and the presentation of certificates.

In order to make the courses accessible to those less well-off we also offer (in so far as possible) a **Bursary Rate Fee.** We also offer an interest-free fees **Payment Plan** option.

The payment of fees is arranged between the participant and SHEP Finance Team who can be contacted if you have a query. It is a deliberate policy in SHEP not to involve Trainers in the collection of participant fees: this is to allow the Trainers to focus on their work with participants. However, should you experience difficulty the important thing is to talk to someone in the Project, and this may include approaching a Trainer if this is what you wish to do.

#### Depending on the course you may be able spread the payments over a number of months

Our preference is to receive the balance of the fee in one payment when the course place is being offered. We appreciate this is not possible for everyone. For the moment, for most courses, SHEP operates an interest-free fees **Payment Plan**. This means that the cost of the course may be paid over a number of months (though not longer than the length of the course) on a monthly basis, by **Standing Order**. If this option is available, and if you wish to apply for it, you will need to complete the Payment Plan Form and Standing Order Mandate (which you will receive with your letter of offer) and return them to SHEP by the agreed date before the course commences. <u>Please do not arrange</u> the Standing Order independently of SHEP - it needs to be done through the SHEP Finance Dept.

#### You may be able to source some grant support yourself

Some participants have been supported by their employers or by their Local Development Partnership to undertake training with SHEP. Other participants have received assistance from the Department of Social Protection. St Vincent de Paul has also provided support to some applicants who met certain requirements. SHEP cannot make such applications on behalf of participants, but we encourage you to make your own enquiries.

#### SHEP offers a Bursary Rate Fee for some courses

SHEP recognises that for some people, the course fee, even though it is a subsidised fee, may still be prohibitive. The **SHEP Bursary Fund** (to which people and companies have made donations) is a small fund which helps us to make some of our courses more accessible to those facing financial difficulties. We also get some funding from the HSE each year to support concessions. The number of Bursary Rate Fee places available for any SHEP course will depend on money available in the SHEP Bursary Fund, along with any funding available from the HSE. Priority is generally given to SHEP's two foundation courses (the SHEP Certificate in Personal Development and the SHEP Certificate in Social Awareness and Community Empowerment).

#### Eligibility to apply for a SHEP Bursary Rate place

You may apply for a Bursary Rate place if you are

- i) a social welfare recipient or
- ii) a full-time student or
- iii) if you are experiencing financial hardship.

Criteria are as follows:

- i) a social welfare recipient in receipt of one of the following Social Welfare benefits/allowances:
- Blind Person's Allowance
- Carer's Allowance
- Carer's Benefit
- Disability Allowance
- Working Family Payment
- Farm Assist
- Illness Benefit
- Invalidity Pension
- Job Seeker's Allowance
- Job Seeker's Benefit
- One Parent Family Payment
- ii) Supplementary Welfare Allowance full-time student: you may apply for a bursary rate place by submitting a letter setting out your case.
- iii) financial hardship: if you are in receipt of one of the following payments and are experiencing financial hardship -Guardian's Payment, Pre-Retirement Allowance, State Pension Widows/Widower or Surviving Civil Partner's Pension; or if you are in other difficult financial circumstances, you may apply for a bursary rate place by submitting a letter setting out your case.

There is a very limited amount of money available in the SHEP Bursary Fund for bursary rate places. We cannot guarantee therefore that all applicants will be successful. Please note bursary rate places will be awarded to those who meet the eligibility criteria on a **'first-come, first-served'** basis. **Early applications have an advantage.** 

#### How to apply for a Bursary Rate Funded Place:

To apply, you must complete and submit the standard Course Application Form and also enclose the following:

- A completed Bursary Rate Place Application Form
- **Evidence** of your receipt of the relevant Social Welfare payment <u>or</u> (if you are **not** a social welfare recipient) a letter setting out your case for a Bursary Rate Place

#### How applications are processed

All of the applications for Bursary Rate places will be assessed by the Director. All applicants for Bursary applicants will be notified of the result when course places are offered. Those who don't qualify for a Bursary Rate places, it is important to remember that, for most courses, a Payment Plan can be arranged to pay the remainder of the fee in instalments over the duration of the course. Details of how to do this will be enclosed with the course place offer.

#### You must apply for each course

It is important to note that Bursary Rate places must be applied for each time you apply for a course – if you received a Reduced Fee or a Funded Place previously you must apply for it again for your next course and there is no guarantee you will be successful.

#### What happens if you have financial difficulties?

The Project understands that from time to time a participant may experience difficulties with the payment of fees. The Project will be as supportive as possible and will make every reasonable effort to accommodate participants with financial difficulties. However, if such a situation arises, it is essential for the participant to contact either the Financial Administrator, the relevant Training and Development Officer, or the Director (in confidence) <u>as soon as possible</u> so that a suitable arrangement can be put in place.

A participant who has not paid the fee in full (and who has not made arrangements with SHEP to pay the balance) will not receive a Certificate (or a Statement of Attendance).

#### What happens if you leave the course before it ends?

It is the policy of The Social and Health Education Project that if a participant leaves the course before it ends he/she is liable to pay in full the cost of training delivered up to his/her last date of attendance, as well as a sum amounting to 20% of the cost of the remainder of the course and that in such instances the initial deposit if also forfeited.

# Frequently Asked Questions for course in Kerry-Limerick combined Spring 2024

# Who is this course for? The training is designed

- As Part Two of the SHEP Foundation Programme, the first part being the Personal Development course you have just completed
- As a continuation of your personal journey of growth and development, through deepening your awareness of the wider social relationships with which you are involved
- As an alternative entry point than the Personal Development course, to SHEP's training pathways, so as to include participants whose main starting interest was their community, their involvement in a local organization, or who want to bring deeper awareness to their involvement

# What are the aims of this course?

The course aims to develop and deepen awareness of how we relate and co-operate in groups and communities, how we are shaped by the society we grow up in and how we, in turn, shape society through our lives and actions. As such the course is a continuation of a journey of awakening awareness, as to how we are in relation to ourselves and those around us, however with a widened focus for that inquiry. Through facilitated experiential exploration of these themes the course aims:

- to develop awareness of how we are **shaped by the society** we grow up in and how we, in turn, shape society through our lives and actions
- to deepen awareness and knowledge of the impact of **wider systems** on our personal development and wellbeing
- to enhance participants' ability to work on, and explore themes together, especially in relation to finding ways of working towards a better society for all
- to develop understanding and **confidence to act** in ways that represent a **balanced response to both individual and group needs**
- to develop awareness and the skills required for effective participation as active citizens
- to provide a focus and a starting point for those who aspire to be more involved in **community**, whether it is at a local, national or international level

# Themes around which awareness grows through the course?

- Roles within groups
- Working co-operatively in a group situation
- Behaviour in groups
- Dealing with conflict constructively
- Leadership styles
- Talents, skills and strengths in leadership
- Why society is the way it is now
- What changes are needed and what we can do

- What the important issues in our community are
- How do realities of Gender, Power, Diversity, inter-culturalism, justice ... impact our lives
- Values
- Development, environmental challenges and sustainability

#### Is assessment part of the course?

Participants are not required to undertake any written work and there are no formal assessments or examinations. However, for their own benefit, participants are encouraged to record their learning during the course in a personal learning journal.

#### What is the methodology used?

Experiential group work is used throughout the course, providing opportunities for participants to make discoveries firsthand, instead of hearing or reading about others' experiences. Through active involvement, reflection and sharing, participants find meaning and gain knowledge from their own experience and the group becomes a learning community. This process allows participants to learn new skills, new attitudes or even entirely new ways of thinking.

#### How big will the training group be?

The group will normally consist of 18-24 participants, facilitated by 2 trainers.

#### Will I get a certificate?

Certificates will be awarded to those who have attended a minimum of 80% of the course.

#### Where and when will the course be held?

The course will be 74 hours with a mix of on-line and in-person. There are 8 x 3 Wednesday evening on-lines session. One weekend at a Limerick venue and one weekend at a Tralee venue. One Saturday will be online and another Saturday in-person at a venue to be confirmed.

#### How much does the course cost?

The cost of the course in Kerry-Limerick in Spring 2024 is €550 with a limited number of places of €250 (on award of a bursary of €300).
